- Organize strategic side-events and awareness raising conferences.
- Maintain strong partnership relations with like-minded policy influencers.
- Organize regular online planning sessions to develop joint intervention strategies with key allies.
- Conduct research, gather and share information on concerning international policies / treaties, and write policy briefs and media articles.
- Supporting politically persecuted states and Christians.

Key policy focus areas

Dangerous policy key words threatening life, family and freedom:

- Comprehensive Sexuality Education (CSE) - sexualizing children
- Sexual and Reproductive Health and Rights (SRHR) - abortion rights
- Sexual Orientation & Gender Identity (SOGI) - LGBT promotion
- Global Governance - unaccountable power concentration vs national sovereignty

- A high-level international policy network established and effective in influencing policy at the US, Canada, UN, EU, and ACP level.

1. PROJECT NORTH-AMERICA

With an office in Washington, DC, (and maybe Ottawa) CCI would be positioned to, from a Christian perspective, effectively engage with the government and civil society groups in the United States and Canada on life, family and freedom, nationally and worldwide, and at the Organization of American States, which unites Member States from Latin America, the Caribbean, the US, and Canada.



2. PROJECT UN GENEVA

Based in an office in the middle of the United Nations Human Rights Center in Geneva, we focus our Christian and legal advocacy on the Human Rights Council, the Office of the High Commissioner for Human Rights, the various bodies that oversee human rights treaties and the World Health Organization. We provide Christian and legal resources to representatives of member states from all parts of the world in support of human dignity protection on a Christian basis.



3. PROJECT UN NEW YORK

Our official consultative status to the United Nations enables us to maintain a full-time presence at the world's foremost international body. From a Christian perspective we provide legal expertise to Member States, their representatives and capitals, to ensure protections for the inherent dignity of every human person as image bearer of God. Our specific areas of focus are the General Assembly, the Economic and Social Council, and a variety of high-level commissions and other influential UN entities.



4. PROJECT EUROPE

Situated in Brussels, the capital of the European Union, we bring a Christian voice and provide expert advice to the European Parliament, where we are accredited, as well as to the European Commission, and Council of Ministers, advocating for initiatives and improvements in the fields of life, family and freedom that affect all of Europe.

In Strasbourg we follow the monthly plenary sessions of the European Parliament and also targeted cases of the European Court of Human Rights. In Vienna we engage with the Organization for Security and Co-operation in Europe and the Fundamental Rights Agency of the European Union.



5. PROJECT AFRICA

CCI is situated in a strategic and central location in Africa in Nairobi. Kenya is an influential country on the continent and houses the headquarters of the United Nations. From there, we influence countries and their representatives individually and at a high level. We also monitor the agendas of the Ethiopian-based African Union, the Pan African Parliament in South Africa as well as the Organization of African (48), Caribbean (16) and Pacific (15) States. Further, we monitor the implementation of policies such as a recently signed, but not yet ratified, secularly charged EU trade treaty with this group of 79 countries.



6. OFFICE NETHERLANDS

Our headquarters is located in Bodegraven, in South Holland, where it all began in 2013. It is strategically located near the Dutch government center The Hague. It provides an ideal base from which to coordinate our advocacy efforts around the world. From here we direct our offices in the fields of operation and we will work on the fundraising, the communication with the support base and all other general administration, also for our two other branches in the US and Canada.
